VOLUNTARY ANNOUNCEMENT

INCREASE IN SHAREHOLDING BY A DIRECTOR

This is a voluntary announcement of Jiangnan Group Limited (“**Company**”) to inform its shareholders and potential investors of the increase in shareholding by a director (“**Director**”) of the Company.

The Company has been informed by Mr. Chu Hui (“**Mr. Chu**”), the chairman and the chief executive officer of the Company and an executive Director, that Power Heritage Group Limited (“**Power Heritage**”), a controlling shareholder (within the meaning of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited) of the Company which is wholly owned by Mr. Chu, acquired 1,000,000 ordinary shares (“**Shares**”) of the Company (representing approximately 0.02% of the total issued share capital of the Company as at the date of this announcement) on the open market for a total consideration of HK\$1,070,000 on 5 April 2017.

Immediately following completion of the above acquisition of Shares by Power Heritage, Mr. Chu (together with Power Heritage) would be interested in 1,424,524,000 Shares (excluding 1,000,000 Shares granted but not yet vested to Mr. Chu under the share award scheme adopted by the Company on 9 September 2015), representing approximately 34.92% of the total issued share capital of the Company as at the date of this announcement.
