SHARE PURCHASE PURSUANT TO SHARE AWARD SCHEME

Reference is made to the announcement of Jiangnan Group Limited (the “**Company**”) dated 9 September 2015 (the “**Announcement**”) in relation to the adoption of the share award scheme (the “**Scheme**”) by the board of directors of the Company (the “**Board**”). Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as defined in the Announcement.

Following the Company’s instruction, on 16 October 2018 and 18 October 2018 the Trustee used the cash of the Scheme to purchase 166,000 shares and 1,432,000 shares of the Company’s existing Shares at the aggregate consideration of HK\$63,275.01 and HK\$549,713.65 on the market for the purpose of the Scheme, respectively (the “**Purchase**”).
